1. **BOOKLET.** Obtaining and reading “The Volunteer Mission Experience.” Available from the NACCC office (800) 262-1620 for \$4.00. [They will bill you.]
2. **APPLICATION.** Completed and sent in by **February 1, 2010.**
3. **ENDORSEMENT.** Letter of endorsement from your minister (or in absence of minister a church officer). If you don’t have a minister note it and notify Jack Brown.
4. **FEE.** Participation fee, **\$375.00**, due **February 15, 2010.** Make check to Olivet Congregational Church [memo line: Mission Mazahua Trip – 2009]
5. **DOCUMENTS.** Travel Documents: Valid Passport. Government issued Phot I.D. Minors must also have **notarized** letter from both parents authorizing this trip to Mexico, a **notarized** letter granting permission to treat. [*Notarized within week before trip*] You are responsible to have all of your documents with you for your **return** to the U.S. including your Tourist Pass receipt.
6. **INSURANCE.** Medical Insurance (your responsibility)
7. **AIRFARE/AIRLINE TICKETS.** Airfare to and from Mexico City after acceptance notification. The earlier you purchase tickets, the less expensive they will be. If you plan to stay over for a touring day, be sure to make allowance for that in your flight arrangements
8. **REPORT.** Report after trip of your experience. [We use these to evaluate what we are doing and as publicity and promotion for future trips.]
9. **QUALITIES.** Flexibility, cooperation, collegiality, positive attitude, generous spirit, willingness to do your part (and a little more), friendly disposition, Christian conduct, affirmation of Mission Mazahua’s policies, faith in God for everything.

Please note:

Volunteers should note that, although unlikely, they may be asked to leave the mission field at any time, with or without cause. Your signature (and for minors the signatures of your parents) on this application indicates that you have considered and accept and will abide by all conditions and policies included in the accompanying information packet and on this form.
